We, the undersigned, urge all legislators to actively support SB 47, the *Petition DISCLOSE Act* (Allen).

SB 47 requires signature gatherers for ballot initiative petitions to show voters the three largest funders paying for their signature-gathering before they sign. It has rules to ensure that signature gatherers must show the true names behind the signature-gathering instead of misleading names even if funders try to hide behind front groups. Let the voters know!
